**1 – ADMISSION LISTS**

All the Heads of High Schools/Higher Secondary Schools (Govt. / Public Sector Institutions) affiliated with the Board, are required to send/dispatch complete lists of admissions made in Class IX (Science & General / Arts Regular groups) for the academic year 2021-2022 to the undersigned upto 29<sup>th</sup> September -2021 or earlier.

**2 – ENROLMENT**

The date for filling-in the Enrolment Forms of regular candidates only through affiliated High Schools / Higher Secondary Schools (Govt. / Public Sector Institutions) is open with immediate effect till 11<sup>th</sup> October- 2021. For this purpose, the blank enrolment forms can be obtained on any working day from Assistant Secretary (Stores) of the Board, upon requisition letter subject to payment of Rs.100/- (Rupees One Hundred) only towards cost of enrolment form.

**3 – SCHEDULE FOR RECEIPT OF ENROLMENT FORMS AT BOARD'S OFFICE**

The enrolment forms duly filled-in and completed in all respects, from the affiliated High School / Higher Secondary School of Govt. / Public sector, will however be received / accepted at Board's office, on the dates given below against each district, without any fee, as per Govt. orders.

Prior to forwarding the enrolment forms, it should be ensured by the Head of High School / Higher Secondary School that:-

a.	No regular candidate of Class IX should below age of 12 years.
b.	The particulars of the candidate i.e Name/Father's Name/Surname and Date of Birth are recorded / written carefully in accordance with the School General Register under the signature of the candidate and authentication by the Head of School concerned, as well.
c.	Recent passport size colored photographs with blue background should be pasted with gum upon the enrolment form, at the prescribed place / box. One photograph shall be signed & stamped by the Head of School concerned.

In case of non fulfillment of above conditions (a, b & c), the enrollment forms will be rejected at the risk and cost of the candidate and institution concerned.

Before submitting the enrolment forms duly completed in all respects, the following documents are essential to be produced by the Head of High School / Higher Secondary School.


a.	Covering letter duly signed by Head of Institution showing number of enrolment forms.
b.	Two copies of lists of the candidates (in full) in alphabetical order, showing the date of admission in the institution with class, date of birth and School G.R No.
c.	Two copies of fee statement.
d.	Original Bank Instrument / Banker's Cheque / Demand Draft / Pay Order or Bank Challan duly deposited at HBL BISE Booth.



All the Heads of affiliated High Schools / Higher Secondary Schools are requested to please comply-with the above instructions in letter and spirit and circulate the contents of this notification amongst candidates, parents and the masses.
