1. Institutions are required to Log on to the Board's website www.biseatd.edu.pk for online registration module for 1st Year regular students and submit the same alongwith requisite fee within due date. In case of delay in submission of registration, late fee will be charged. (For details/query contact 0992-390153, 0314-5000363 FOR PORTAL & 0992-392727 FOR REGISTRATION during office hours).
2. Registration forms must be filled Group Wise i.e. Pre-Medical, Pre-Engineering, Computer/General Science, and Humanities.
3. The provisional admission can, however, be allowed after 03-11-2021 to 03-12-2021 to facilitate real hardship cases of students of Government and Private Institutions subject to approval by the Chairman of Board as admissible under Chapter XVI Clause No. 3 of Board Calendar and on submission of prescribed application forms alongwith requisite fee.
4. Provisional admissions cannot be taken as admissible on regular basis till the same is approved by the Chairman and if in his opinion, the reasons of late admissions are not sound and convincing, he can reject such applications. It may please be noted that no student be admitted after 03-12-2021 under any circumstances.
5. In case of re-admission in class 1st Year on the old registration number, the same shall be provided for necessary information to Registration Section, if otherwise eligible. (For query regarding eligibility criteria, please contact registration section).
6. The Head of institutions are directed to collect fee and other charges from the student at the end of every month. Otherwise complaint of the institution regarding fee and other charges against the students at the time of migration to other Institution/Board shall not be entertained.
7. No institution is allowed to admit a migrating candidate under any circumstances without having original migration certificate issued by BISE concerned.

8. College to College Migration (Local Migration) will not be allowed under any circumstances after **January 31, 2022**.
9. Registration forms of only those private institutions shall be entertained which are registered with KP-PSRA. Moreover, Registration letter issued by KP-PSRA for the Session 2021-2022 must be attached.
10. The Head of the Institutions are required to submit the following documents for regular student(s), migrated from other Board, alongwith registration forms.
- Verified SSC DMC (Board Concerned)
 - Verified DMC Part-1(regular student) from Board concerned.
 - Registration forms along with covering letter duly signed by the Head of Institution Concerned.
 - Original Migration Certificate.
 - Original Receipt of prescribed fee.
