- 5.ELIGIBILITY: CSS Competitive Examination Rules notified vide SRO No.1452(I)/2018 dated 27.11.2018, amended vide SRO No. 1516(I)/2021 dated 27.11.2021shall apply, mutatis mutandis, to Special CSS except following modifications inserted vide Rule 22 of the Rules ibid Published vide SRO No.1906(I)/2022 dated 14.10.2022:-
  - (i) Upper age limit will be 32 years (vide Rule 22 of the rules ibid). Two years relaxation in upper age limit to the categories specified in Rule 6(2) would also be admissible.
  - (ii) For Special CSS Exam one additional/ fourth chance\* would be admissible.
