## <u>NOTICE</u>

In continuation to earlier notice dated 23-11-2022, the Punjab Public Service Commission announces that the five (05) candidates were provisionally cleared for interview. The shortlisted candidates were called for interview. Out of five (05) candidates, one (01) candidate remained absent, three (03) candidates were rejected as they did not possess requisite experience and only one (01) candidate was allowed to appear in interview provisionally on account of deficient documents. But, the candidate interviewed provisionally did not submit the requisite deficient documents within stipulated time which resulted in the cancellation of his candidature. Therefore, in the light of PPSC Policy Decisions – 2016 [P.D.17.8 (a)] the following next <u>05</u> available candidates in the merit list for recruitment to <u>01</u> **POST OF ASSISTANT DIRECTOR (ADMIN) (BS-17) ON CONTRACT BASIS FOR THE PERIOD OF THREE (03) YEARS, EXTENDABLE UPTO FIVE (05) YEARS, IN THE INFORMATION AND CULTURE DEPARTMENT (PUNJAB JOURNALISTS HOUSING FOUNDATION) have been provisionally cleared for interview as a result of written test held on 30-10-2022.**
