- 6. The candidates appearing in this examination are essentially required to attached copies of their Registration Slips and previous mark Sheets of 1st year, else the Board shall be constrained to withhold their admit cards. The consolidated result of such candidates will not be finalized.
- 7. The candidates should fill their Examination Forms in their own hand writing legibly in capital letters in accordance with particulars of their registration in order to avoid any subsequent complications or problems.
