## Dear Candidate,

Referring online application and subsequent appearance in Screening (MCQ) Examination and Physical Standard of Fitness for the subject post, under mentioned candidates are advised to furnish **BIO-DATA along with attested copies (with name stamp of attestation officer) of requisite documents as mentioned below, within 15 days of placement of this Notice on FPSC website, through Registered Post/Courier to determine their eligibility. It may however, be understood that asking of requisite documents should not be inferred that they have been shortlisted for interview and their eligibility in all respects in terms of advertised conditions shall be determined after scrutiny of their documents:** 

- a. <u>Bio-data</u> form duly signed and filled-in completely (<u>CANDIDATES ARE ADVISED TO DOWNLOAD THE</u> <u>GENERAL RECRUITMENT BIO-DATA-FORM FROM THE OFFICIAL WEBSITE OF FPSC i.e.</u> <u>https://fpsc.gov.pk/downs/forms)</u>
- b. Two latest **Photographs** (Passport size).
- c. Valid Computerized National Identity Card (CNIC).
- d. Self **Domicile** Certificate (SDC).
- e. Secondary School Certificate <u>(SSC)</u>/Matric (showing date of birth) and Higher Secondary School Certificate <u>(HSSC)</u>/ Intermediate issued by Secretary, Board of Intermediate and Secondary Education. In case of 'O' level and 'A' level or other then Board of Intermediate and Secondary Education an equivalence certificate from Inter Board Committee of Chairmen (IBCC).
- f. <u>Bachelor's degree. PHYSICAL STANDARD OF FITNESS: (i) Minimum Height: for male 5'- 6" or 168 cm and for female 5'-2" or 157 cm. (ii) Minimum Weight: for male 106 Lbs or 48.1 Kg and for female 45 Kg or 99.2 Lbs. (iii) Minimum Chest Measurement: For male 32 <sup>3</sup>/<sub>4</sub>" or 83 cm, Expanded 34 <sup>3</sup>/<sub>4</sub>" or 88 cm.</u>
- g. Degree(s) and Transcripts/ Result-Cards/ DMCs showing duration of study period, **proof** of CGPA/ Grade/ Class with credit hours and **Result Declaration Date**, issued by Controller of Examination from a University recognized by Higher Education Commission (**HEC**) to determine eligibility.
- h. **Experience** Certificate (Post Qualification) with Job description and exact dates as per detailed Experience Format (Annex-A available on FPSC's website), **where applicable**.
- i. Wherever an <u>equivalence of the required degree</u> is to be claimed by a candidate, an equivalence certificate issued by HEC/PEC/PMC/PMC/PMC as the case may be, furnished to FPSC to authenticate the claim.
- j. Valid <u>**Registration**</u> with PMC/PEC/PVMC/PNC/PCATP/Bar Council and such other institutions where applicable (if any).
- k. In case of <u>Government Servant</u>, Original Departmental Permission Certificate (<u>DPC</u>) showing exact date of appointment and domicile on FPSC's prescribed format (available on FPSC's website) duly signed and stamped by Head of the Department/ Division/ Ministry (Official stamp must be affixed).
- In case of <u>Non-Test</u> Case or <u>UNDERTAKING</u> provided by the candidate at the time of examination, <u>Original</u> <u>Treasure Receipt (TR)</u> being application fee deposited on or before the closing date of the advertisement in the Government treasury or in a branch of National Bank of Pakistan or in a State treasury, authorized to transact business on behalf of Government.
- m. Medical Certificate (if required/advertised) and Proof of Age Relaxation (if claimed).
- n. Scanned/ Photo copies of any educational credential/ above mentioned documents will not be added to application folders of candidates unless attested in original by the attesting authority.
- o. In case candidates belonging to <u>Ex-FATA/Gilgit Baltistan and AJK</u> regions, Annex-B and Annex-C certificates respectively (format available on FPSC's website), <u>where applicable</u>.
- p. The eligibility of the candidates with regard to Physical Standard of Fitness as advertised will be determined on the basis of Medical Examination to be arranged by the ASF, Ministry of Aviation.
